### **SUPPLY AND INSTALLATION OF MEDICAL EQUIPMENT AND FURNITURE FOR KAYUNGA AND YUMBE HOSPITALS**

The **Government of the Republic of Uganda** *has received* financing from the OPEC Fund for International Development (OFID), the Arab Bank for Economic Development in Africa (BADEA) and the Saudi Fund for Development (SFD) (hereinafter called “the Funds”) towards the cost of the **Rehabilitation and Expansion of Kayunga and Yumbe General Hospitals Project**, and it intends to apply the proceeds of this Loan towards payments under contracts for supply and installation of medical equipment and furniture for Kayunga and Yumbe Hospitals as follows:

**1) Lot1: Supply and Installation of Medical Equipment in the following 4 sub-lots:**

Sub-Lot A: Supply and Installation of Laboratory Equipment

Sub-Lot B: Supply and Installation of Surgical and Critical Care Equipment + Surgical Instruments

Sub-Lot C: Supply and Installation of General Medical Equipment

Sub-Lot D: Supply and Installation of Imaging Equipment

**2) Lot 2: Supply and Installation of Medical and Hospital Furniture**

**3) Lot 3: Supply of Non-Medical Furniture**

The Ministry of Health now invites sealed bids from eligible bidders for Procurement of the Medical Equipment and Furniture. Bidders may bid for one or more Lots or Sub-Lots. However, each Lot or Sub-Lot must be tendered for separately and shall be evaluated independently. Each Lot or Sub-Lot shall be awarded as a separate contract

Bidding will be conducted through the International Competitive Bidding Procedures as specified in the Guidelines for the Procurement of Goods and Contracting for the Execution of Works issued by the Development Institutions Members of the Coordination Group (First Edition 2001).

Interested eligible applicants may obtain further information and inspect the Bidding Documents at the Procurement and Disposal Unit of the Ministry of Health Headquarters at the address below from 08:00 to 12:30 and 14:00 to 17:00 on Mondays to Fridays. A set of the Bidding Document, in English, may be purchased by interested bidders on submission of a written application to the address below and upon payment of a nonrefundable fee of UGX100,000 or an equivalent amount in freely convertible currency **for each Lot**. The method of payment will be by Bank. Bank Payment Slips are issued from the Ministry of Health Headquarters Cashiers’ Office.

Bids should be submitted in sealed envelopes, delivered to the Ministry of Health at the address below by 18<sup>th</sup> January 2019 at 14:30 hours East Africa Standard Time and be clearly marked “*Bid for Supply and Installation of Medical Equipment and Furniture (Lot No .....Sub-Lot ....., as appropriate.)*”.
