### INVITATION FOR BIDS

TENDER NOTICE : 001/W/2021-2022/ICB/RTDA-BADEA&OFID

PROJECT : NYACYONGA-MUKOTO ROAD PROJECT: UPGRADING OF NYACYONGA-MUKOTO ROAD SECTION (36 KM).

1. The Government of the Republic of Rwanda (GoR) has received financing from the ARAB BANK FOR ECONOMIC DEVELOPMENT IN AFRICA (BADEA) AND THE OPEC FUND FOR INTERNATIONAL DEVELOPMENT and intends to apply part of the agreed amount for the loan to payments under the contract for the "Nyacyonga-Mukoto Road Project: Upgrading of Nyacyonga-Mukoto Road Section (36 km)".
2. The Rwanda Transport Development Agency (RTDA) / Ministry of Infrastructure (MININFRA) now invites sealed bids from eligible bidders for the procurement of above works, following International Competitive Bidding (ICB) procurement method. The execution period of works is Thirty-Six (36) calendar months.
3. Due to Covid-19 protection measures, interested eligible bidders may obtain further information from upon their request on Email: [procurement@rtda.gov.rw](mailto:procurement@rtda.gov.rw) / [info@rtda.gov.rw](mailto:info@rtda.gov.rw).
4. A complete set of Bidding Documents written in English may be obtained by interested bidders through their official emails, upon submission to the emails [procurement@rtda.gov.rw](mailto:procurement@rtda.gov.rw) and [info@rtda.gov.rw](mailto:info@rtda.gov.rw) payment proof for a non-refundable fee of One Hundred Thousand Rwandan Francs only (100,000 FRW) or in a convertible currency deposited on Rwanda Revenue Account Opened in any commercial Bank in Rwanda.

5. An optional site visit is scheduled on 19/07/2022 and all prospective bidders are advised to participate. The venue for departure is RTDA headquarters, at 09:00 a.m. local time.
6. Well typed technical and financial Bids properly bound in 4 copies, including one (1) original and three (3) copies of each bid and clearly marked "Technical offer or financial offer accordingly and indicating the title of the tender must be delivered to the above mentioned office not later than 26/08/2022 at 10:00 a.m. local time (GMT+2) and must be accompanied by a Bid Security, in a form of a reputable Bank Guarantee only of an amount equivalent to One hundred and Fifty Thousand United States Dollars (150,000 USD) or its equivalent amount in a freely convertible currency. The bid security should be included in the technical bid.
7. The original and all the copies of the Technical bids shall be placed inside of a sealed envelope clearly marked "Technical bid", "Name of the tender ", reference number, name and address of the bidder and with a warning "Do Not Open until (insert the time and date of the bids submission deadline). Similarly, the original Financial bid shall be placed inside of a sealed envelope clearly marked "Financial offer/bid" followed by the name of the tender, reference number, name and address of the bidder, and with a warning "Do Not Open with The Technical Proposal." The sealed envelopes containing the Technical and Financial bids shall be placed into one outer envelope and sealed. This outer envelope shall bear the submission address, tender document reference number, the name of the tender, and shall be clearly marked "Do Not Open Before [insert the time and date of the submission deadline indicated in the Data Sheet".
8. Technical Bids will be opened in the presence of bidders' representatives who choose to attend, on the same day, on 26/08/2022 at 10:30 a.m. local time (GMT+2) at RTDA premise, 2<sup>nd</sup> floor, conference room. The financial offers for technical qualified bidders will be opened on the date that shall be communicated to qualified/ substantially responsive bidders.
9. The bids will remain valid for a period of One Hundred and Twenty (120) days from the date of bids submission.
