The Government of Mozambique has obtained a credit (hereinafter “loan”) from the Arab Bank for Economic Development of Africa (BADEA) for the financing of the Construction of a Fisheries and Marine Technology Polytechnic Institute in Inhambane Province, Mozambique and it is intended that part of the proceeds of the said loan be applied towards the cost of the providing Laboratories Equipment.
2. The Ministry of Education and Human Development (MINEDH) through the Department of Acquisitions (DAQUI), now invites sealed tenders from eligible bidders for the Supply of Laboratories Equipment for the Fisheries and Marine Technology Polytechnic Institute in Inhambane Province, Mozambique.
3. Bidding will be conducted through International Competitive Bidding (ICB) procedure specified in the BADEA Guidelines for the Procurement of Goods and Contracting for the Execution of Works, 2001 and is open to all eligible Bidders as defined in the Procurement Regulations.
